Police Department

Chief Campbell gave the Chief's Report.

Public Works

Councilmember Johnson wanted to discuss the condition of the sidewalks and the need to be landscaped. Mr. Campbell explained one of the employees had to be put on Light Duty for a short period of time and told her we will see that it gets done as soon as possible.

Public Comment

Michaela Hicks, who was in the audience, has been complaining about an odor in the water at her home for quite some time and asked had the problem been fixed yet. She stated she is not the only one complaining about this issue and this was corroborated by Linda Smith (audience) and Councilmember Leger.

Mr. Campbell was not sure if Mrs. Hicks was referring to the repair of the aerators that has been a recent project of the City and asked if that was what she was referring to and she stated yes. He explained the aerators have nothing to do with the water supply but are used for the chemical reactions of the treatment pond before it is treated and then sprayed to re-enter the aquifer system. The aerators are still under repair as we are waiting for a part to come in before they can be put back in place. We have been in contact with EPD (Environmental Protection Division), and there are no hazards to the water supply as the aerators, again, have nothing to do with the water supply. The aerators do help with the smell from the treatment pond but not inside homes. Mrs. Hicks stated that it is still a problem and asked if we have any idea when this will be taken care of. Mr. Campbell told her, since he is not sure what is the source of the smell she is encountering, he will be happy to contact Bill Gerber, who is a Class I Certified Water and Wastewater Operator contracted with the City of Coolidge, and let him know about the issue and concerns of citizens.

Earlier in the meeting, Mr. W.C. Smith, who was in the audience, raised his hand to ask a question, and Mayor Causey told him he would have a chance to speak before the meeting was adjourned. At this time, Mayor Causey asked Mr. Smith if he would like to address Chief Campbell with any questions or concerns. Mr. Smith stated that Chief Campbell had answered most of his questions during his Chief's Report concerning recent automobile break-ins around town. He stated he understands we have recently hired a part-time officer but that the break-ins seem to be occurring sometime between midnight and 4:00 a.m., so he would like to have an officer patrolling during those hours if possible. Chief Campbell thanked him for his questions and input.

Councilmember Johnson added that there has also been concern from some of the women in the community who live by themselves. If something happens and there is not a City Police Officer on duty, they have to call the Sheriff Department to have a Deputy come and it takes anywhere from 20-40 minutes for them to get here. She is also concerned for the employees of the Dollar General store, who are mostly women, when they have to close the store at night because they have had two robberies already in the past. She wanted to know if we have a solution to have an officer patrolling more in the evenings. Chief Campbell agreed with Councilmember Johnson that we do need an officer here during those hours for the safety of the store owners and employees and told her he looks forward to conversation with Mr. Cole, once he starts as the City Manager, to come up with a solution.

At this time, the public was asked to leave the Council Room for Council to go into Executive Session for Personnel.
